

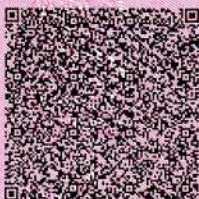

This memorandum of understanding (MoU) is signed on this day of 19, June, 2026 between Department of Assamese, JDSG College, Bokakhat, Assam, which hereafter to be called as 'First Party' and is represented by its HoD Rachna Padi Pegu.

And

Naharjan High School, Naharjan, Bokakhat, Assam, which hereafter to be called as 'Second Party' and is represented by its Head Master & Member Secretary, Mr Diganta Hazarika.

Whereas both parties have made this memorandum of Understanding for greater cooperation in the areas of collaborative activities, value based education, teachers training and orientation and programs that involve upliftment of teaching learning situations.

THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

1. The second Party will be considered as an adopted educational institution of the First Party hereafter.
2. The first party will hold programs for overall upliftment of the teaching learning situation in the school premise of the second party.
3. The first party will give opportunity to the students of the second party to visit laboratories of the First Party.
4. The First Party will organize need-based orientation programs/lecture programs for both teachers and students of the second party.
5. The first party will extend help in creating a green landscape in the school premise of the second party.
6. Talks on environment time to time will be organized by the First Party in school premise of the second party.
7. The first party will conduct career oriented program for the students of the second party.
8. The second party will provide logistics whenever a program is initiated by the first party in the school premise of the second party.
9. **Limitation:** This MoU excludes any financial transaction between the two parties for holding any program/event.

10. **Duration:** This MoU is valid for three years. Either party may terminate this MoU by providing a written termination letter to the other party.
11. **Modification:** Modification can be done through proper consultation between the two parties.
12. **Disputes:** Any dispute concerning the interpretation and application of the MoU shall be settled through consultation or negotiation between the parties.
